INSTRUCTIONS TO APPLICANTS (page 1 of 2)

- 1. Applications shall be accepted from members of The Southeast Section Ninety-Nines. Please be sure to include your membership number on the Official Application.
- 2. <u>Application submission</u>: Please submit your **FULLY COMPLETED** application packet electronically to <u>NewHorizonScholarship@SESection99s.org</u>.
- 3. The application shall require information about an applicant's aviation background, aviation goals, and specific plans for the use of the scholarship.
- 4. The applicant shall be an active member of The Ninety-Nines® for one year prior to submitting application for the New Horizons Scholarship.
- 5. The scholarship application shall be signed either in ink or electronically to attest that the information contained therein is true and correct.
- 6. Scholarship winner will be notified within 8 weeks of the submission deadline.
- 7. All award money will be paid to a flight school or flight instructor.
- 8. The recipient must use the funds for the scholarship within 14 months from the official notification of receiving the scholarship.
- 9. Continuation of funding is dependent on uninterrupted active membership with The Ninety-Nines® during the scholarship award period.

- How are you active in The Ninety-Nines[®]?
- What you feel uniquely qualifies you for this scholarship?
- How do you plan to fund the remain training if these funds do not cover all the cost?
